SERVICES WILL NOT BE AVAILABLE ON:

Weekends (with the exception of Give Parents a Break events on the 2nd Saturday of each month, and Youth Centers on Saturday), all federal holidays, any additional days observed as a federal holiday to include Executive Orders (cancellations are on a case-by-case basis for Family Child Care (FCC) providers, sports activities, and off-post SKIES *Unlimited* classes), and some training holidays. Information will be made available in advance, whenever possible, of additional periods of reduced service and/or non-service as determined by CYS personnel.

SPECIAL CONSIDERATIONS:

If Killeen ISD closes school early (instead of a scheduled early-out) and post remains open:

Youth Centers: Teen Taxi will transport youth as normal.

SAC: Children enrolled in an after-school SAC program will be picked up from the school and transported to their normal SAC site for parent pick up. Children attending Venable Village Elementary will be picked up and transported to Walker SAC. Children not enrolled in after-school care will not be accepted.

CDC Pre-Kindergarten: Children enrolled in an after-school care program in the CDC will be picked up from the school and transported to their normal CDC for parent pick up. Children not enrolled in after-school care will not be accepted.

If post closes early but Killeen ISD keeps normal hours:

<u>Child Care</u>: Parents will be expected to pick up their children from CYS child care programs no later than 1 hour after post closure.

<u>After-school care</u>: Due to post being closed, CYS will not provide transportation; parents will need to pick up their children directly from school.

Enrichment Activities: Scheduled Kids On Site care, SKIES *Unlimited*, and sports activities will be cancelled on a case by case basis. Parents should ensure that their older children will be able to get home.
